### Financial update

The financial position is strong and looks good for the foreseeable future.

Treasurer needs a debit card

### Any Other Business

Grants available from Blaby District Council- need to apply for Christmas celebration funding now.

Proposed idea – contact in Glenfield can produce gift food boxes as cost of £5 per box to be delivered with calendar and card.

Calendars to be a selection of photos of old Whetstone (and current). Call out for photos on Facebook and to service users / volunteers. Extra copies to be ordered for sale. Helem to coordinate.

Face to face meeting of befrienders to be held as soon as Covid restrictions allow. This has been an extremely successful and valuable service. Ullesthorpe Garden Centre to be used as venue at £6 per head.

The weekly chip shop run will stop until later in the year (September / October) as numbers now reducing.

Up to 10 service users will still need support so local businesses to be contacted to see if they can provide take away meals on a weekly basis (Lime Tree, Waterbridge, Rainbow Tree).
